The Somerville Museum brought an Economic History Lecture Series to the community in collaboration with several other community organizations, including the Welcome Project and the Somerville Council on Aging. The series was supported by the Museum through a grant from Massachusetts Humanities. 500 people benefited.

4c (Code:) (Expenses \$ 2,500. including grants of \$ 2,500.) (Revenue \$ 0.) The Somerville Museum initiated a Community Curator Seed Grant Program to encourage talented individuals with interest in Somerville's local history or culture to put forward ideas for future exhibitions within a competitive program. Within this program, two Community Curators were awarded a seed grant of \$1,250 in FY17. A subcommittee of the Trustees, headed by the Chair of the Program Team chooses the winners. The Trustees elect to not award a seed grant if the applications do not in their judgment warrant an award.

Question 20(b)

The Somerville Historical Society has been in operation since 1898, serving the public throughout that time. For most of its existence, it was not required to make filings with the IRS because of the modest level of its revenue. That changed in 2007 when the IRS adopted new filing requirements applicable to small non-profits. Unbeknownst to the organization, and without prior notice, the public charity status of the organization was automatically revoked in August 2010 for failure to make the necessary filings under the new requirements. Upon petition and reapplication by the organization, the IRS reinstated the organization's public charity status in February 2012, retroactive to the date of revocation.
